

**Olmsted Parks Conservancy Spring Membership
Drive Paddle Board Drawing**

Official Rules

NO PURCHASE NECESSARY TO ENTER TO WIN.

A PURCHASE OR PAYMENT WILL NOT IMPROVE YOUR CHANCES OF WINNING.

Eligibility. The Olmsted Parks Conservancy Paddle Board Drawing is open to all residents of the 50 United States and District of Columbia, who are at least 18 years old at the time of entry. Void outside the USA, in Puerto Rico, the US Virgin Islands, and other United States territories and possessions. The Conservancy will not pay for shipping. The drawing is subject to all applicable federal, state, and local laws and regulations as is void where prohibited by law. During the drawing promotion dates, all Olmsted Parks Conservancy sustaining members are automatically entered into the drawing.

Sponsorship. The drawing sponsor is Olmsted Parks Conservancy, located at 1299 Trevilian Way. Sponsor and its respective affiliates, successors, agents, representatives, officers, trustees, committee members and employees, and any entity involved in the development, production, implementation, administration, judging or fulfillment of the drawing, including without limitation, the immediate family members of such individuals are not eligible to participate. Sponsor will conduct the drawing substantially as described in these Official Rules.

Entry Period. The drawing promotion begins May 7, 2022 at 12:01 AM EST and ends May 14, 2022 at 11:59 PM EST.

How to Enter. During the entry period, all sustainers and anyone making a gift are automatically entered to win. For those wishing to enter without donating, email info@olmstedparks.org and provide basic contact information, including your name, street address, phone number, and email address. (NOTE: You must submit all required fields with information that is valid on the date of the drawing to be eligible.) All information becomes the property of Olmsted Parks Conservancy and by providing, you consent to receive future communications.

Limitations and Entries. LIMIT ONE ENTRY PER PERSON. No third-party entry or entry through any drawing service is permitted. Any person who attempts or otherwise encourages the entry of multiple or false contact information under multiple identities or uses any device or artifice to enter or encourage multiple false entries, as determined by the Sponsor, will be disqualified. Use of robotic entry devices is prohibited.

Grand Prize. One (1) Paddle Board will be awarded. Winner agrees to accept the Grand Prize "as is" and entrants hereby acknowledge that the Sponsor is in any manner responsible or liable for any warranty, representation, or guarantee relative to the Grand Prize, including warranties provided by the prize supplier. Approximate retail value of the Grand Prize is \$750.00. Any difference between the stated approximate retail value and actual value of the Grand Prize will not be awarded. Winner is solely responsible for any federal, state, and local taxes.

Drawing. A winner will be selected in a random drawing from among all eligible entries collected during the Entry Period taking place on or about May 18 at Sponsor's principal place of business. The drawing will be conducted by the Sponsor, whose decisions and interpretations on all matters relating to the Drawing and these Official Rules are final and binding in all respects. Sponsor reserves the right to disqualify any entrant or winner and may refuse to award a prize to a person who is not eligible or has violated a rule, gained unfair advantage in the drawing, or obtained winner status using fraudulent means. If there is a dispute about the identity of an entrant, prize will be awarded to the natural person to whom the email address is assigned by the internet service provider responsible for the domain associated with the submitted address. If winner is found to be ineligible or not in compliance with the Drawing rules, winner will be disqualified and an alternate winner will be awarded the prize in a separate random drawing. Winner will be notified by telephone. Inability of the Sponsor to contact winner by telephone within seventy-two (72) hours after selection, may result in disqualification of winner and an alternate winner may be selected in a random drawing at Sponsor's discretion. The Paddle Board will need to be picked up from the Sponsor headquarters, 1299 Trevilian Way, Louisville, KY 40213, within fourteen (14) days after the winner has been notified and accepted the prize.

Odds. The odds of winning depend on the number of eligible entries received, according to the eligibility requirements in the Drawing.
